

Table – Dated Versions of Pieces in Piano/Vocal Scores from *Séance on a Wet Afternoon* with Lengths of Each in Numbers of Pages and Measures

(Referred to on p. 309 and p. 389, note 90, in Paul R. Laird, *The Musical Theater of Stephen Schwartz: From Godspell to Wicked and Beyond*)

This table illustrates which excerpts appear in each score consulted for this study with an indication of number of pages and measures. Some excerpts are separate in earlier scores, usually indicating that these later became part of larger sections. The sources listed above do not illustrate every stage of the opera's development. The earliest collection of files includes some of Schwartz's first work, leading up to the second file that presents Act 1 as it existed for the Seagle workshop in summer 2007. The third file represents Schwartz's subsequent revisions, and transmits the opera's state not long before the January 2008 Act 1 AOP workshop. During late 2007 and into 2008, Schwartz worked on Act 2. The version of both acts from September 2008 includes Schwartz's revisions following Val Verde and would have been close to what was heard at the November 2008 AOP workshop. Revisions from that event appear in the December 2008 score, and the last two sources show more or less what was heard in Santa Barbara and New York City.
